I understand that, as a result of giving this consent, if I am suspected of being the person named in a criminal record for one of the sexual offences listed in the schedule to the <i>Criminal Records Act</i> in respect of which a pardon was granted or issued, that record may be provided by the Commissioner of the Royal Canadian Mounted Police to the Solicitor General of Canada, who may then disclose all or part of the information contained in that record to a police force or other authorized body. The police or authorized body will then disclose that information to me. If I further consent in writing, to disclosure of that information to the person or organization referred to above that requested the verification, that information will be disclosed to that person or organization.
